3. We understand that the tuition is in addition to the pre-paid, non-refundable registration fee.
4. We understand and agree that if our child is withdrawn in the first semester, tuition will be reimbursed on a prorated basis ONLY if the vacancy is able to be filled while maintaining full enrollment within the age group. We will be held responsible for total tuition if our child is withdrawn during the second semester.
5. We understand and agree that full tuition is expected for the first and second child enrolled from a family, and a 10% tuition discount will be given for any additional children attending St. Thomas at the same time.
